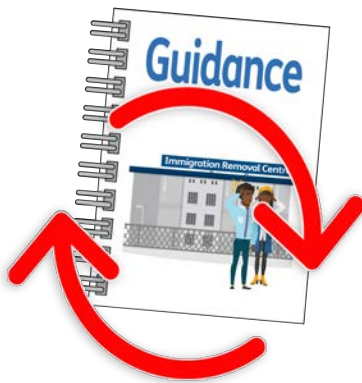
NHS England and NHS Improvement are looking at introducing new **guidance** about moving people in an **immigration removal centre** to and from mental health hospitals.

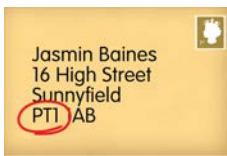

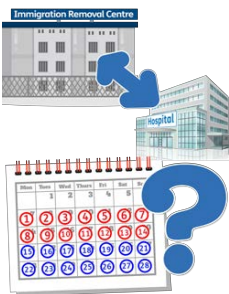
